#### Financial Report: Franco Sepede

- \$160,048.81 Current Balance (as of 6/13/2017)
- Bank account linkage to quick books
- Bank assignors; process to update with bank painful but completed; appropriate ISSA assignors registered/ updated
- No Financial Statement (data transferred from bank account; automated entries from bank; duplicate entries from manual entries – Franco to review and remove any duplications/errors)
- Proposal to take portion of funds into 9-month CD (ISSA name) to gain some interest; minimize risk
  - o Recommendation to take \$75,000 into 9-month CD / stagger over 3 months in increments of \$25,000
    - July \$25,000
    - August \$25,000
    - September \$25,000
  - o 18 month cash reserves
  - Discuss operating expenses/costs (Reserves to cover worst case scenario / liability)
  - Motion to approve Franco and Renata
- Purchase another desktop computer/PC for office
